Reference: Network Integration Transmission Service Agreement

Dear Mr. Brown:

On December 6, 2011, you submitted for filing on behalf of Southwest Power Pool, Inc. (SPP): (1) an executed service agreement for network integration transmission service between SPP as transmission provider and Kansas Electric Power Cooperative, Inc. (KEPCO) as network customer; and (2) an executed network operating agreement between SPP as transmission provider, KEPCO as network customer, and Westar Energy, Inc. as host transmission owner. Pursuant to authority delegated to the Director, Division of Electric Power Regulation – Central under 18 C.F.R. § 375.307, your submittal in the above referenced docket is accepted for filing to become effective October 1, 2011.

Notice of the filing was issued on December 7, 2011, with comments, protests, or interventions due on or before December 27, 2011. No protests or adverse comments were filed. Under 18 C.F.R. § 385.210, interventions are timely if made within the time prescribed by the Secretary. Under 18 C.F.R. § 385.214, the filing of a timely motion to intervene makes the movant a party to the proceeding, if no answer in opposition is filed within fifteen days. The filing of a timely notice of intervention makes a State Commission a party to the proceeding.

This action does not constitute approval of any service, rate, charge, classification, or any rule, regulation, contract, or practice affecting such rate or service provided for in the filed documents; nor shall such action be deemed as recognition of any claimed contractual right or obligation affecting or relating to such service or rate; and such action is without prejudice to any findings or orders which have been or may hereafter be made

by the Commission in any proceeding now pending or hereafter instituted by or against any of the applicant(s).

This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to 18 C.F.R. § 385.713.
