

## 2023 ITP Preliminary Battery/Storage and Conventional Siting Plans Posting

- **Action Required**

The 2023 ITP preliminary battery/storage and conventional siting plans have been posted to [GlobalScape](#) for stakeholder review. SPP staff requests that stakeholders review these draft siting plans, provide feedback affirming the inclusion of sites posted and provide notification and corresponding material associated with requested exceptions to include in the solar and wind siting plans. Exceptions will be presented for approval by the Economic Studies Working Group in an upcoming meeting.

- **Entities Required to Provide Feedback:** All interested stakeholders

- **Due Date and Method of Submittal**

Stakeholders should submit any feedback **by May 24, 2022** via the [SPP Request Management System \(RMS\)](#), using the “Submit Information” **Request Template**, “Integrated Transmission Planning (ITP)” **Subtype 1**, and “Data Submission” **Subtype 2**.
