**ADMINISTRATIVE**

Chair Alan Myers (ITC Great Plains) called the meeting to order at 8:01 a.m. CT. He and MOPC staff secretary Lanny Nickell (SPP) reviewed proxies, new members, action items, the Revision Request (RR) summary, and upcoming draft motions.

Lanny Nickell shared the 2023 Working Group Effectiveness Survey results with the committee and pointed out key indicators, feedback, and suggestions for continuous improvement.

**APPROVAL ITEMS (2-9)**

*Ray Bergmeier (Konza Transmission Company) moved and Steve Sanders (Western Area Power Administration—Upper Great Plains) seconded to approve the consent agenda with the exclusion of items 2.e.viii and 2.f.i. The motion passed unanimously with 100% approval.*

*Larry Holloway (KPP Energy) moved and Richard Ross (AEP Southwestern Electric Power Company) seconded to approve 2.e.viii RR603 (SIR657) GI Study Deposits as presented. The motion passed with 86% approval.*

*Steve Sanders (Western Area Power Administration—Upper Great Plains) moved and Jason Mazigian (Basin Electric Power Cooperative) seconded to approve 2.f.i Judson Remedial Action Scheme as presented. The motion passed with 99% approval.*

### 3. **Transmission/Economic Studies Working Groups**

Derek Brown (Evergy), Calvin Daniels (WFEC), and Nick Parker (SPP) reviewed the 2025 Integrated Transmission Plan (ITP) Assessment Scope with the committee. *Derek Brown (Evergy) moved and Steve Gaw (Advanced Power Alliance) seconded to approve the 2025 ITP Scope as presented.* The motion passed with 100% approval.

### 4. **Supply Adequacy Working Group/Resource Energy Adequacy Leadership Team**

a. Colton Kennedy (OPPD), Chris Haley (SPP), and Kim O’Guinn (SPP) detailed RR606, which was the Planning Reserve Margin (PRM) Development Process compliance filing. *Adam Graff (Heartland Consumers Power District) moved and Larry Holloway (KPP Energy) seconded approve RR606 as approved by SAWG. Steve Gaw (Advanced Power Alliance) moved to amend the motion by adding “as modified by CAWG and modified by SPP staff.” Chase Smith (Southern Power Company) seconded Steve’s motion. The motion to amend the original motion passed with 99% approval.* The amended motion—approve RR606 as approved by SAWG, modified by CAWG, and modified by SPP staff—passed with 90% approval.

b. Colton Kennedy (OPPD) provided an overview of the Maintenance Outage Policy. *Adam Graff (Heartland Consumers Power District) moved and Heather Starnes (Missouri Electric Commission) seconded to endorse prioritizing outage policy critical for winter planning reserve margin while delaying*

*additional components of the outage policy.* The motion passed with 99% approval.

c. Colton Kennedy (OPPD) and Raleigh Mohr (SPP) reviewed the Resource Availability Policy (RR605) discussions with the committee. He noted that final language for RR605 would be targeted for approval at the April 2024 meeting.

## 5. **Transmission Working Group**

a. Derek Brown (Evergy) presented RR577 (SIR631) Persistent Operational Issues Enhancements to the committee. *Derek Brown (Evergy) moved and Steve Gaw (Advanced Power Alliance) seconded to approve RR577 as presented.* The motion passed with 90% approval.

b. Derek Brown (Evergy) detailed RR592 (SIR643) BP7250 GI Manual Fuel-Based Dispatch Option 2 for the committee. *Derek Brown (Evergy) moved and Heather Starnes (Missouri Electric Commission) seconded to approve RR592 as presented. Heather Starnes moved to amend the original motion by adding "effective with DISIS 2022 Phase 2 and DISIS Phase 2023 Phase 2." Carrie Dixon (NextEra Energy) seconded Heather's motion.* The motion to amend the original motion failed with only 61% approval. The original motion—approve RR592 as presented—passed with 80% approval.

c. Steve Purdy (SPP) explained the Holistic Integrated Tariff Team (HITT) T1: Capacity Resource Interconnection Service Deliverability concept to the committee. *Mike Wise (Golden Spread Electric Cooperative) moved and Bill Dowling (Midwest Energy) seconded to approve option 5 for CRIS deliverability areas and development of revision requests necessary to implement them.* The motion passed with 98% approval.

## 6. **Staff**

Sunny Raheem (SPP) updated the committee on SCRIPT C1: CPP Phase I Assessment Type and Transition plan. *Heather Starnes (Missouri Electric Commission) moved and Jim Flucke (Evergy) seconded to approve the initial policy direction for CPP Phase 1 assessment inclusion and transition plan.* The motion passed with 100% approval.

## 7. **Project Cost Working Group**

Brian Johnson (AEP) presented RR574, which focuses on BP7060 and covers the In-Service Date Report. *Brian Johnson (AEP Southwestern Transmission) moved and Jason Mazigian (Basin Electric Power Cooperative) seconded to approve the revised RR574 BP7060 In-Service Date Delay Report Submission as presented. Brad Cochran (OGE Transmission) moved to amend the original motion by adding "using 180 days rather than the proposed 90 days as the trigger for PCWG review." Mo Awad (Evergy Kansas Central) seconded Brad's motion.* The motion to amend the original motion failed with only 52% approval. The original motion—approve the revised RR574 BP7060 In-Service Date Delay Report Submission as presented—passed with 83% approval.

## 8. **Market Working Group (RTWG)**

a. Richard Ross (AEP) and Micha Bailey (SPP) detailed planned implementation of the HITT M1 congestion hedging policy outlined in RR591 (SIR12). *Richard Ross (AEP Southwestern Electric Power Company) moved and Chase Smith (Southern Power Company) seconded to approve RR591 as presented.*

The motion passed with 82% approval.

b. Richard Ross (AEP) and Yasser Bahbaz (SPP) outlined the Uninstructed Resource Deviation Charge covered in RR578 (SIR626). *Jim Fluke (Evergy) moved and Jim Jacoby (AEP Public Service Company of Oklahoma) seconded to approve RR578 as presented. John Varnell (Tenaska) made a motion to table RR578 until SPP established a Value Estimation and Editing (VEE) process. His motion died for lack of a second.* The original motion—to approve RR578 as presented—passed with 100% approval.

9. **Regional Tariff Working Group** (TWG)

Robert Pick (NPPD) and Nicole Wagner (SPP) proposed a revision to Schedules 7, 8, 9 and Attachment H of the SPP tariff detailed in RR600.3. *Robert Pick (Nebraska Public Power District) moved and Jason Mazigian (Basin Electric Power Cooperative) seconded to approve RR600.3 as presented.* The motion passed with 100% approval.

## INFORMATIONAL (10-16)

10. **Staff**

Kim O'Guinn (SPP) and Casey Cathey (SPP) provided a resource adequacy update and reviewed the 2024 work plan, which included target timelines for approving several revision requests.

11. **Staff**

CJ Brown reviewed December 2023 operating conditions, provided a brief update on Winter Storm Heather, and shared a look ahead to the remainder of 2024.

12. **Staff**

Paul Suskie (SPP) updated the committee on the status of each category in the Holistic Integrated Tariff Team (HITT) program.

13. **Staff**

Jennifer Swierczek (SPP) updated the committee on the progress of the generator interconnection backlog mitigation plan as well as process improvements.

14. **Staff**

Natasha Henderson (SPP) delivered a quarterly Integrated Transmission Plan (ITP) report to the committee. She pointed out several upcoming timelines in the report. Natasha also covered the status of the Decision Quality recommendation seven from the Strategic and Creative Re-engineering of the Integrated Planning Team report.

15. **Market Working Group**

Richard Ross (AEP) shared information that the Market Working Group reviews monthly and educated the committee on its purpose.

16. **Staff**

Lanny Nickell (SPP) reviewed the 2024 corporate goals and associated policies to be developed per quarter.
