ADMINISTRATIVE

Chair Alan Myers (ITC Great Plains) called the meeting to order at 8:15 a.m. CT. He and MOPC staff secretary Lanny Nickell (SPP) reviewed proxies, new members, action items, the Revision Request (RR) summary, and upcoming draft motions.

Jason Mazigian (Basin Electric Power Cooperative) moved, and John Stephens (City Utilities of Springfield, Missouri) seconded, to approve the consent agenda with the exclusion of item 2d. The motion passed with 100% approval.

3. **Economic Studies Working Group / Transmission Working Group**
2024 ITP Assessment

Sunny Raheem and Kirk Hall (SPP) reviewed the 2024 ITP Assessment with the committee and noted the drivers, sensitivities, and benefits of the study. Derek Brown (Evergy) detailed the Transmission Working Group's (TWG) considerations on the study. Calvin Daniels, chair of the Economic Studies Working Group (ESWG), spoke about the value of the portfolio and its connection to previous winter weather events. *Derek Brown (Evergy) moved, and Aaron Doll (Empire District Electric Company) seconded, MOPC endorse the 2024 ITP recommended plan, which includes recommended issuance, modification, and withdrawal of NTCs for projects within the four-year financial commitment window, and stage projects addressing winter weather needs as those that address persistent operational needs per the staging waiver. This vote includes the approval of the ITP Manual staging waiver.* The motion passed with 95% approval.

Derek Brown (Evergy) moved, and Ray Bergmeier (Konza Transmission Company) seconded, MOPC endorse the 2024 ITP Assessment Report as documentation of completion of the ITP planning process specified in SPP OATT Attachment O Section III. The motion passed with 100% approval.

4. **Transmission Working Group**

a. RR651 (BP7250) GI Manual Solution Process Methodology

Derek Brown (Evergy) reviewed the proposed GI Manual Solution Process Methodology with the committee. This proposal revises BP7250 GI Manual language to allow upgrades approved mid-DISIS study from other planning processes to be considered as potential mitigations for constraints identified during the ongoing DISIS study. *Derek Brown (Evergy) moved, and Steve Gaw (Advanced Power Alliance) seconded, MOPC approval of RR651 (BP7250) GI Manual Solution Process and Methodology as approved by TWG on September 24, 2024.* The motion passed with 93% approval.

b. Provisional Load Policy Recommendation

Derek Brown (Evergy) shared the proposed Provisional Load Process with the committee. This process will allow Transmission Customers to add load to our region using their planned generation. *Derek Brown (Evergy) moved, and Richard Ross (AEP Southwestern Electric Power Company) seconded, MOPC approval of the Provisional Load Process Policy Proposal.* The motion passed with 100% approval.

5. **Market Working Group**

Richard Ross (AEP Southwestern Electric Power Company) provided an overview of RR638 Day-Ahead Reliability Unit Commitment Self-Commitment Exemption. Removing this exemption will mitigate behaviors in the market where resources are intentionally switching between self status and market status to increase make whole payments, which will achieve a more accurate and economical market

solution. *Richard Ross (AEP Southwestern Electric Power Company) moved, and Jason Mazigian (Basin Electric Power Cooperative) seconded, MOPC approve RR638 DA-RUC Self-Commitment Exemption as presented.* The motion passed with 99% approval.

6. Supply Adequacy Working Group

Colton Kennedy (Omaha Public Power District) detailed RR632 Date Change for Attachment AA for the committee. This proposed revision request allows Load Responsible Entities (LREs) more time to address deficiencies in meeting their Resource Adequacy Requirement (RAR). *Mo Awad (Evergy Kansas Central) moved, and Mark Barbee (Kansas Electric Power Cooperative) seconded, MOPC approve RR632 Date Change for Attachment AA as presented.* The motion passed with 90% approval.

INFORMATIONAL (7-18)

7. Economic Studies Working Group

Calvin Daniels (Western Farmers Electric Cooperative) and Nick Parker (SPP) reviewed the scope for the 2026 Integrated Transmission Plan (ITP)/Consolidated Planning Process (CPP) Transition Study for the committee. This study will facilitate a reliable and economic transmission build out in the SPP region and inform a Network Upgrade Contribution for the CPP.

8. Operating Reliability Working Group

Jeremy Harris (Evergy) and Charles Cates (SPP) delivered a status update on the implementation of FERC Order 881 for the committee.

9. Project Cost Working Group

Angie Anderson (Sunflower) reviewed the delayed upgrades in the Q4 In-Service Date Delay Report Appendix 2. *Mo Awad (Evergy Kansas Central) moved, and Matt Caves (Western Farmers Electric Cooperative) seconded, MOPC accept the current estimated In-Service Date as reasonable and acceptable to be used to evaluate future In-Service Date deviations.* The motion passed with 91% approval.

10. Transmission Working Group

a. HVDC Process Previews

Derek Brown (Evergy) and Sunny Raheem (SPP) previewed the new High Voltage Direct Current (HVDC) process being implemented via RR650, which is anticipated for approval at the committee's meeting in January 2025.

b. RR642 HITT T3 Phase 2 Tariff/Business Practice

Derek Brown (Evergy) updated the committee on the progress of RR642 which covers HITT recommendation T3, a modification to implementing new load additions. This revision request is tentatively targeted for approval during the committee's October 2025 meeting.

11. Consolidated Planning Process Task Force

Sunny Raheem and Tessie Kentner (SPP) provided an update to the committee on the implementation of the Consolidated Planning Process as well as the compliance approach to FERC Order 1920.

12. Staff

Paul Suskie and Brent Wilcox (SPP) updated the committee on SPP's efforts and progress to comply with plans to implement the refund order and resettlement plans.

Clint Savoy (SPP) shared an update on the status of the MISO-SPP Joint Targeted Interconnection Queue (JTIQ) effort.
14. **Staff**
Jennifer Swierczek (SPP) shared the latest update on the GI Backlog Mitigation plan as well as the associated

Kirk Hall (SPP) updated the committee on the Integrated Transmission Plan (ITP) studies currently in progress. He noted that the 2024, 2025, and 2026 ITP Assessments are in green status and on track based on the schedule.

Seth Mayfield (SPP) updated the committee on the implementation of FERC Order 2222. He noted the responses to SPP’s initial compliance filing and the overall timeline to file another response with FERC no later than December 26, 2024.
